INDIVIDUAL AUTHORIZER INFORMATION SHEET

Why become an Assistive Devices Program (ADP) Individual Authorizer (IA) for Communication Aids?

- Enhance clinical skills with simple technology for individuals with writing and speaking difficulties in various environments.
- Better serve your clients who might have AAC needs before they are able to be seen by a General or Expanded Level Augmentative Communication Service.
- Professional/ clinical development which contributes to your continuing education for your college.
- Access to ADP funding for a range of communication devices, written communication aids, artificial larynges and voice amplifiers.
- Access to AAC clinical resources and equipment through the Centralized Equipment Pool (CEP).

What resources are available to you as an IA?

- Access to AAC resources on the CEP Community of Practice.
- Access to workshops offered by CEP (see Course Workshop Registration at https://web.cepp.org/)
- Access to equipment loan kits for FREE from CEP.

How to find an IA in your area?

Becoming an IA (SLP and OT):

- You must be registered with the College of Audiologists and Speech Language Pathologists (CASLPO) or with the College of Occupational Therapists of Ontario (COTO).
- All OT and SLP's are required to complete the online IA Home Study Guide and Individual Authorizer Workshop before applications are submitted to ADP.
- Register online at www.cepp.org under Course Workshop Registration. Register for **both** the Hands-On IA Workshop and the Online IA Home Study Guide. The total cost of the process is \$100 (\$50 per course).

Step 1: OBTAIN APPLICATION

SUMMARY OF STEPS TO BECOME AN IA:

Obtain the registration form to become an IA for Communication Aids from the ADP website: https://www.ontario.ca/document/assistive-devices-program-health-care-professionals/register-authorizer-or-vendor

Step 2: ONLINE IA HOME STUDY GUIDE

When CEP receives your registration and payment, you will be sent information to set up a username and password for the IA Home Study Guide. Review it PRIOR to attending an IA workshop, but complete the FINAL TESTS AFTER you have attended the IA Hands-On Workshop.

Step 3: WORKSHOP AND FINAL TESTS

Attend an IA Hands-On Workshop. This is an in-person opportunity to gain hands-on experience with AAC equipment and to complete interactive case studies. Workshops are held about three times a year across the province. Dates and locations are posted on the CEP website. Complete the 2 final tests in the online IA Home Study Guide after the workshop.

Step 4: CEP LETTER OF COMPLETION

This will be emailed to you when both requirements (online home study and hands-on workshop) have been met. This needs to be sent to ADP along with your IA application and other required documentation.

Step 5: SEND APPLICATION & DOCUMENTS TO ADP (adpauthorizers@ontario.ca) Refer to the ADP checklist for Authorizers: <u>Authorizer Applicant Checklist</u>

NOTE: If you work at an AAC Clinic, a Letter from your Clinic Manager is required. Include: a) effective date of employment; b) date of completion of the Foundations in AAC course; and c) clinic number.

Step 6: ADP will review the application and send your IA number.

NOTE: Be sure to keep your email and mailing addresses current with ADP to receive updates and maintain your status as an IA.
